Eligible Training Provider List

The SWDB, through the one-stop center, must make available to customers the State list of eligible training providers.

The list includes:

- a description of the programs,
- performance, and
- cost information.

Eligible Training Providers

Eligible Providers are:

- (1) An **institution of higher education** that provides a program that leads to a recognized postsecondary credential;
- (2) A **registered apprenticeship provider**; or
- (3) Another **public or private provider of a program of training services** and eligible providers of adult education and literacy activities under title II ***if such activities are provided in combination with occupational skills training.***

Eligible Training Programs

A program of training services is one or more courses or classes, or a structured regimen, **AND** leads to:

- An industry-recognized certificate or certification,
- A certificate of completion of a registered apprenticeship,
- A license recognized by the State involved or the Federal government,
- An associate or baccalaureate degree,
- A secondary school diploma or its equivalent;
- Employment; or
- Measurable skill gains toward a credential described above.

Eligible Training Provider Requirements

The Governor, after consultation with the SWDB, shall establish **criteria, information requirements, and procedures** regarding the eligibility of providers of training services to receive WIOA training funds.

Criteria and Information Requirements

The following shall be taken into account:

- The **performance** of providers of training services
- The need to **ensure access to training services throughout the State**, including in rural areas, and through the use of technology
- The degree to which the training programs relate to **in-demand industry sectors and occupations in the State**
- The requirements for **State licensing of providers** of training services

Criteria and Information Requirements

- Ways in which the criteria can **encourage the providers to use industry-recognized certificates or certifications**
- The **quality** of a program of training services, including the **ability of a program to provide a recognized postsecondary credential**
- The ability of the providers to deliver training services to individuals **who are employed** and individuals with **barriers to employment**
- Whether the provider is in a **partnership with business**
- **Other?**

Data Collection Requirements

- Name, Type, Description of Provider
- Name, Description of Program; Length; Pre-Reqs; Format
- Name of Credential; CIP & SOC Codes
- Cost, tuition, fees, supplies, etc.
- Individuals Enrolled; Completed
- Credential and skill attainment; wages; employment
- Age, race & ethnicity, barriers to employment
- Other?

Performance Information

- Employment rate 2nd quarter after exit
- Employment rate 4th quarter after exit
- Median earnings in the 2nd quarter after exit
- Credential attainment
- Measurable skills gain
- Program completion rate

Possible Committee Role

- Assist in improving application, registration, and assessment
- Advise on setting priorities
- Review and consider equity, quality, and value

- Streamline information publication
- Consider larger context of supply & demand
- Waiver approval
